Dear Parents,

An update of Students' COVID-19 Vaccination progress in January 2022

As required by EDB, a school will only be allowed to resume whole-day face-to face classes, luncheons and extra-curricular activities if a minimum of 70% of teachers, school staff, students aged 18 years or above have received two doses of COVID-19 vaccine (Sinovac or BioNTech) for more than 14 days as well as students aged 12 to 17 years have received one dose of COVID-19 vaccine (BioNTech) for more than 14 days. Meanwhile, the level-based whole-day class resumption will be allowed if students of the concerned level(s) attain 70% vaccination rate.

In view of this policy, the school is going to conduct a survey to update students' vaccination percentage in hope of fine tuning the arrangement of face-to-face class resumption.

You are invited to complete the survey concerning the vaccination record or progress of your daughter in this e-circular on or before 13 January 2022. Please read carefully the following options and choose the appropriate one.
