## **Updated Guidelines on Reporting COVID-19 Testing and Quarantine Measures**

With the recent development of COVID-19, the School would like to draw your attention to the following guidelines for various situations.

	Situation	What to do
1.	The student is a confirmed or preliminarily tested positive case of COVID-19.	
2.	The student is classified as a close contact person of a confirmed case of COVID-19 by the CHP.	Parents are required to inform class teachers at the earliest possible time.  Also, the student should not go to school.
3.	The premises where the student lives have been categorized as compulsory testing specified place.	She should follow the Government's requirements to undergo COVID-19 testing or quarantine accordingly. She can
4.	The student who has stayed in the compulsory testing specified place for more than 2 hours received the CHP or "LeaveHomeSafe" COVID-19 exposure notification to undergo COVID-19 testing.	only return to school when her test result is negative.
5.	Household members who live with the student (including domestic helpers) have contacts with people of confirmed cases and are categorized by the Government as close contact persons.	Parents should inform class teachers of the situation. Despite students of these categories may not require to take the
6.	Household members (including domestic helpers) who live with the student have visited premises with confirmed cases and are required to undergo compulsory testing in accordance with the arrangement by the Government (they are not categorized as close contact persons).	compulsory COVID-19 testing, for the safety and health of all members of the school, kindly arrange and take your daughter to do the testing. She can return to school when her test result is negative.
