Dear Parents,

Quality Education Fund e-Learning Funding Programme – Provision of subsidizing schools to purchase mobile computer devices for loan to needy students (2021/22 School Year)

Under the Fourth Strategy on Information Technology in Education, the Education Bureau (EDB) has been promoting e-learning through the use of mobile computer device. The COVID-19 epidemic has accelerated the development of e-learning. When face-to-face classes have not yet fully resumed, primary and secondary schools have deployed diversified teaching and learning strategies flexibly (including e-learning) based on schools' context and students' needs at different learning stages in supporting students to learn at home, achieving "suspending classes without suspending learning".

Looking forward, blended mode of learning, i.e. face-to-face classes together with learning at home with electronic or other modes of learning, may become the "new normal" in teaching and learning. In this connection, the Steering Committee of the Quality Education Fund, in response to the recommendations of the Government, has set aside \$2 billion to launch a three-year programme from the 2021/22 school year. Public sector primary and secondary schools (including special schools) and Direct Subsidy Scheme schools could apply for funding to purchase mobile computer devices for loan to needy students. This ensures all students have equal opportunities in accessing e-learning so that schools could effectively implement blended mode of teaching and learning under the new normal to facilitate learning and teaching.

Eligible families are now invited to apply for the assistance programme. Please complete the attached Parent / Guardian Consent Form on or before 28 January 2022.

優質教育基金電子學習計劃一資助學校購買流動電腦裝置供有經濟需要的學生借用 (2021/22 學年)

教育局透過「第四個資訊科技教育策略」鼓勵學校使用流動電腦裝置促進電子學習。及至 2019 冠狀病毒病疫情爆發,加速了電子學習的發展。在停課和面授課堂未全面恢復期間,各中小學校均按其校情及學生在各學習階段的不同需要,靈活運用不同的學與教模式(包括電子學習),支援學生在家繼續學習,讓學生達至「停課不停學」。
